


### **GENERAL NOTES**



- THE ETHERIDGE SHIRE COUNCIL AND ALL RELEVANT SERVICE AUTHORITIES SHALL BE NOTIFIED IN WRITING A MINIMUM OF SEVEN (7) 2. DAYS PRIOR TO THE COMMENCEMENT OF WORKS.
- ALL LEVELS ARE TO A.H.D. AND DIMENSION ARE IN METERS UNLESS OTHERWISE STATED.
- UPON THE COMMENCEMENT OF CONSTRUCTION WORKS, THE CONTRACTOR MUST COMPLY WITH THE RECOMMENDATIONS OF THE 4 ENVIRONMENT PROTECTION AUTHORITY PUBLICATION 'CONSTRUCTION TECHNIQUES FOR SEDIMENT CONTROL'.
- THE LOCATION OF ALL EXISTING SERVICES SHOWN ON THESE PLANS ARE APPROXIMATE AND THEIR EXACT LOCATION SHALL BE PROVEN 5 ON SITE BY THE CONTRACTOR PRIOR TO THE COMMENCEMENT OF ANY WORKS. ANY DISCREPANCIES SHALL BE REPORTED TO THE SUPERINTENDENT.

- PRIOR TO THE COMMENCEMENT OF WORKS. THE CONTRACTOR SHALL PREPARE A SITE SPECIFIC ENVIRONMENTAL MANAGEMENT PLAN 8. TO THE SATISFACTION OF THE SUPERINTENDENT.( NOT APPLICABLE FOR THIS CONTRACT)
- ALL STORM WATER AND CONDUIT TRENCHES UNDER ROAD PAVEMENT AND/ OR UNDER CONCRETE PAVING SHALL WITH APPROVED 9. CRUSHED ROCK AND COMPACTED IN 200 mm LAYERS, ALL AS SPECIFIED.(NOT APPLICABLE FOR THIS CONTRACT)-N/A


