Agreement to urgent maintenance work

The landowner (licensee) hereby agrees that, in the event of urgent maintenance work required on a grid to alleviate a hazardous situation, where the Council has become aware of the need, and where it has made a reasonable effort to contact them, but are unable to do so within 7 days, and/or for all that repair work not completed within the time stated on a Defect Notice, to pay Council for all costs incurred for the work carried out. Note that this does not relieve the landowner from his responsibility in relation to due diligence and public safety.

Agreement to remove grid and make good

The landowner (licensee) hereby agrees that, in the event of the license being relinquished by the landowner, or cancelled by Council, the landowner (licensee) shall be responsible for removing the grid and appurtenances from the road and reinstating the roadway in accordance with Council's policy. If the removal is not completed by the required time, or to the satisfaction of Council, and Council undertakes the work, the landowner (licensee) agrees to pay Council for all costs incurred in removing the grid.
